In the run-up to this year's Distracted Driving Scholarship competition, the expectation was that the pandemic lockdowns may have impacted the statistics in a positive way, but that does not seem to be the case.

Indeed, despite the dramatically lower number of drivers on the road and miles driven in the United States due to COVID-19, fatalities in Michigan jumped 11% higher in 2021, a rise from even the elevated 2020 statistics. 38 states overall saw increases in traffic deaths, largely due to driver behavior. Michigan and the Midwest region ranked in the top five areas in the nation to see a rise in accident-related fatalities.

"The fact that these numbers continue to rise is of grave concern," says Christensen Law founder Dave Christensen, "and it is ever more important to reinforce the message to our younger drivers about the dangers of impaired, distracted, and drunk driving." That's why the firm continues to encourage awareness through its annual scholarship program.

# **Blog Post**

Every motorist in Michigan is expected to carry auto insurance. Most believe that their policies will protect themselves and any family members who are injured in a wreck. But not so fast — if your auto insurance policy has a step-down clause, you may find that your family members have far less coverage than you think.

A step-down clause — also known as an "intra-family limitation clause" or "intrafamily exclusionary clause" — prohibits family members from collecting the full amount of injury coverage if they are hurt in a wreck, instead reverting to the state bodily injury limit of \$50,000. Insurance companies claim that step-down clauses can prevent fraudulent claims. But in reality, they're unnecessary, as committing insurance fraud is already a crime in Michigan. (See MCL 500.5411(1)).

#### DO I HAVE A STEP-DOWN CLAUSE?

Most consumers are unaware of whether their car insurance policies have step-down clauses. Our attorneys have curated a list of insurers that, at last check, include them in their policies:

If you find that you do have a step-down clause in your policy, it's highly recommended that you change insurers. Serious injuries in a car accident can easily exhaust the Michigan \$50,000 limit.

### HOW AUTO INSURANCE STEP-DOWN CLAUSES HURT MICHIGAN FAMILIES

You may have purchased \$500,000 in coverage for you and your family, but the 50k limit may leave a family member on the hook for any expenses that exceed that amount under a step-down.

#### **HELPFUL TIPS**

- If you don't know, ask. Talk to your insurance agent about the terms of your auto policy. You can also ask a lawyer to review the terms to look for hidden language that could trip up any future injury claims you or a loved one may need to file.
- Spread the word. Tell friends and family members about the dangers of step-down clauses.
- Stuck with a step-down clause? Change insurers. You are far more likely to be injured in a car wreck with a family member as your passenger compared to a friend or non-relative.


# Distracted Driving in Michigan

#### WHAT YOU NEED TO KNOW

Michigan's House of Representatives has made great strides towards saving lives by passing three bills to strengthen the state's distracted driving law and increase penalties for violations. Current Michigan distracted driving law only bans texting while driving. Nothing prohibits a driver from solving the daily Wordle, playing video games, streaming movies, and watching or recording videos behind the wheel — all activities that are just as dangerous as reading, typing, or sending a text message.

#### THE NEW LAW

- HB 4277: Prohibits using mobile electronic devices unless in hands-free or voice-operated mode. Drivers also cannot use devices to access, read, or post on social media or watch, record, or transmit videos.
- HB 4278: Increases penalties for distracted driving. The fine for a first offense increases to \$100 and \$250 for additional offenses. Drivers will also have one point added to their driver's license for a second offense and two points added for subsequent violations.
- · HB4279: Bans all cell phone use for teenagers, even in handsfree or voice-operated mode. Exceptions apply for car accidents, emergencies, and if drivers believe they are in danger.



The next step is for the bills to pass the Senate and go to Governor Gretchen Whitmer to be signed into law.

#### **TEXTING WHILE DRIVING LAWS**

Since 2010, the fine for texting while driving in Michigan has been \$100 for a first offense and \$200 for subsequent offenses However, distracted drivers may also be subject

to civil penalties if they cause accidents that seriously injure others. Victims could be entitled to file a personal injury lawsuit against a distracted driver if their injuries meet the criteria for a serious injury under Michigan law.

#### WHY WE NEED BETTER LAWS

Traffic crash data points to why Michigan needs stronger distracted driving laws. According to Michigan Traffic Crash Facts, 14,236 motor vehicle crashes involving a distracted driver occurred during 2020 in Michigan, 48 of which resulted in a fatality. With a total of 2,213 crashes, Wayne County yielded the highest number of distracted driving accidents. Rear end distracted driving crashes were the most common, accounting for 44.7 percent of all incidents. Nationally, distracted driving claimed 3,142 lives in 2020 according to the National Highway Safety Traffic Administration (NHSTA), making it the cause of 8.1% of all fatalities that year.

These staggering statistics show the grave consequences of distracted driving and reinforce the necessity to strengthen laws to prevent it. Officials support expanding the current distracted driving law because the existing one is difficult to enforce. With texting as the only offense, drivers could easily say they were engaging in another activity and be compliant with the law.

### DISTRACTED DRIVING WRECK-LESS CHECKLIST

helpful tips to keep you safe

- > Put on any accessories such as glasses or sunglasses before starting the car.
- > Adjust seats, headrests, vehicle controls, and mirrors and fasten your seat belt before moving.
- > Keep reading materials and other eye diverters out of reach.
- > Adjust the stereo volume to a level that still allows you to hear emergency sirens do not wear headphones!
- > Enter your destination into the GPS system or phone before moving from a parked position.
- > Stop in a safe area before tending to your children or pets, put the car in park when you stop.
- > Never apply makeup, fix your hair, polish your nails, or change clothes, etc. while driving.
- > Avoid eating or drinking when the car is in motion.
- > No texting, phone calls, taking photos, or other device interaction.
- > Keep your eyes on the road and your hands on the wheel at all times.
